Installation of Bollards - Brogden Road, The Entrance

I refer to your letter dated October 9 2012 in relation to the handling of service request 1466492 relating to the placement of bollards on Brogden Road, North Entrance. This matter has been investigated and I provide the following advice.

Emails received by Council's default email address are in the first instance recorded into Council's document management system prior to issue to the respective section of Council. In this instance the email dated 18 October 2011 was recorded after its receipt and then linked by corporate records staff to a service request which had been logged online around that same time given the request was relating to the same issue and requested by the same customer. The logged service request and corresponding contact phone number from the Precinct Committee was then assigned to field staff and became the basis of the workflow for this request.

Given the nature of the request relating to discretionary works to reduce damage to the road verge caused by vehicles, the request was not given priority relative to other more urgent requests in the system over the wet summer period.

When the service request was formally actioned off, the employee recalled contacting a member of the Precinct Committee via the telephone number on the service request. Investigations have confirmed that the employee spoke with Viviene Soo who was the contact on the service request. The action notes on the service request should have stated that the staff member called the customer as opposed to meeting onsite.

The request nevertheless did take too long to be formally responded to and the customer informed of outcome. Measures have been put in place to prevent this situation developing into the future.

SUBJECT: LEVEL OF SERVICE THAT BEST MEETS THE NEEDS OF OUR COMMUNITY

Dear Michael,

The Entrance Peninsula Community Precinct (TEPCP) is very concerned about the quality of service TEPCP is receiving from Council. Among our concerns is the lack of dialogue by Council when it comes to keeping the community informed about what it's planning staff are negotiating with developers; the continued difficulties TEPCP is having in stopping Council from publishing personal details of people making DA submissions and the unworkable system Council has put in place for Precincts to make Service Requests and receive satisfactory answers.

The purpose of this letter is to document a particular Service Request that TEPCP believes is an example of the difficulties TEPCP is experiencing in trying to get a response from Council. A Service Request that asked Council to please consider a course of action to improve the amenity of our community. A Service Request forwarded to Council in the form of a letter that Council failed to respond to in a timely and satisfactory manner. The facts of this Service Request are these:

- Twelve months ago, on 18th October, 2011, TEPCP emailed Council a letter in pdf format that set out a course of action TEPCP wanted Council to consider,
- A copy of this letter of attached. The letter simply requested that "To improve the amenity of the area TEPCP suggests that Council please consider placing bollards or closely spaced posts along Brogden Road edge to stop vehicle damaging the grass."
- On 24thOctober, 2011, it was lodged as an online service request, Request Number 1466492.
- On Thursday, 29 March 2012, TEPCP emailed Council requesting a response to three outstanding letters of which included Service Request 1466492. A copy of this email is attached which included photos of the damage being done to the reserve.
- On 7th September, 2012 TEPCP emailed Bev Davis, WSC's Precinct 355 Committee Liaison Officer requesting her to please look into this unanswered request for us. Bev Davis was able to reply the same day with advice that stated:

"The SR has been closed (in June 2012) with the comment from Shane Daly - "met with customer onsite and WSC will not be doing this type of works."

TEPCP on 7th September, 2012 immediately responded to Bev Davis (cc'd to Greg McDonald and Julie Vaughan) stating that "This is far from at satisfactory outcome.
 I have no knowledge of Shane Daly meeting any of TEPCP Executive on site and have received no correspondence." and requesting Bev Davis escalate this matter as TEPCP deserves better treatment from Council. The email went on to state:

"This reserve is adjacent to the northern Entrance Bridge abutment and should be kept in first class condition. The Long Jetty reserve has a post and rail fence along it to stop cars and I believe what TEPCP is requesting here is not unreasonable. The Entrance Peninsula Community Precinct Committee (TEPCP) is committed to making The Entrance Peninsula a better place to live. Our Precinct Committee is encouraging residents, businesses and stake holders to take pride in the area and do what they can to improve the appearance and amenity of where we live and work.

Is it too much to ask that Wyong Shire Council to do the same?"

To date TEPCP has not had a response to our 2nd email to Bev Davis on 7th September, 2012.

TEPCP would also like to also make the point that Brogden Road is "One Way" and a rail fence or bollards would stop illegal U Turns and vehicles travelling back the wrong way.

TEPCP requests that Council reconsider Shane Daly's response to the issue that was not relayed at the time to TEPCP and realise that it is the little things, done poorly that undoes all the good work that Council does.
